**PLEADING CYCLE ESTABLISHED FOR COMMENTS ON PETITION FOR ORDER
DECLARING CHANNEL ISLANDS TELEPHONE COMPANY AN INCUMBENT LOCAL
EXCHANGE CARRIER PURSUANT TO SECTION 251(h)(2)
OF THE COMMUNICATIONS ACT**

On June 25, 2008, Channel Islands Telephone Company (CIT) filed a petition for an order declaring CIT to be an incumbent local exchange carrier (LEC) pursuant to section 251(h)(2) of the Communications Act of 1934, as amended, 47 U.S.C. § 251(h)(2), and section 51.223(b) of the Commission's Rules, 47 C.F.R. § 51.223(b). The CIT petition requests that the Commission issue an order and rule declaring that CIT shall be treated as the incumbent LEC in the Channel Islands, California telephone exchange.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **July 31, 2008**, and reply comments on or before **August 15, 2008**. All pleadings should reference **WC Docket No. 08-123**.

In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties are strongly encouraged to file comments electronically using the Commission's ECFS.
