## COMMENT SOUGHT ON A PETITION FILED BY VIRGIN MOBILE USA, L.P. FOR LIMITED DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER IN MASSACHUSETTS

The Wireline Competition Bureau seeks comment on a petition filed by Virgin Mobile USA, L.P. (Virgin Mobile) for a limited designation as an eligible telecommunications carrier (ETC) in Massachusetts. Virgin Mobile is seeking eligibility for Lifeline support only.

Interested parties may file **comments on or before July 31, 2008**, and **reply comments on or before August 15, 2008**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
