PETITION OF AT&T FOR INTERIM DECLARATORY RULING AND LIMITED WAIVERS PLEADING CYCLE ESTABLISHED

WC Docket No. 08-152

Comments Due: August 14, 2008
Reply Comments Due: August 25, 2008

On July 17, 2008, AT&T filed a petition that, absent “comprehensive reform,” seeks interim declaratory ruling and limited waivers regarding access charges.¹ Specifically, AT&T asks the Commission to “clarify the applicability of access charges to interexchange” Internet protocol/public switched telephone network (IP/PSTN) traffic.² In addition, AT&T seeks “limited waivers of [the Commission’s] rules governing [subscriber line charges] and switched access charges.”³

Pursuant to sections 1.415 and 1.419 of the Commission’s rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **August 14, 2008** and reply comments on or before **August 25, 2008**.⁴ Comments may be filed using the Commission’s ECFS or by filing paper copies.⁵ Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of the proceeding, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number, in this case, **WC Docket No. 08-152**. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, “get form.” A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket

or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). **Parties are strongly encouraged to file comments electronically using the Commission's ECFS.**
