On June 18, 2008, Mid-Communications, Inc. dba HickoryTech (Mid-Com) filed a request for review of a decision by the Universal Service Administrative Company (USAC). Specifically, Mid-Com requests reversal of the decision by USAC to adjust Mid-Com's local switching support retroactively for calendar year 2006.

Interested parties may file comments on or before **September 2, 2008**, and reply comments on or before **September 17, 2008**. All pleadings are to reference **WC Docket No. 05-337**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³
