The Region 24 (Missouri) 800 MHz Public Safety Regional Planning Committee will hold its next meeting on Tuesday, September 23, 2008, beginning at 10:00 a.m., at the Missouri State Highway Patrol General Headquarters, Second Floor Conference Room, 1510 East Elm, Jefferson City, Missouri.

The Region 24 800 MHz Public Safety Regional Planning Committee meeting is open to the public. All public safety providers whose sole or principal purpose is to protect the safety of life, health, or property in Region 24 are eligible to utilize these frequencies. It is essential that public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Commission's rules, 47 C.F.R. § 90.523, be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.

All interested parties wishing to participate in the planning for the use of public safety spectrum in the 800 MHz band within Region 24 should plan to attend. For further information, please contact:
