## COMMENT SOUGHT ON STATE OF IOWA PETITION FOR WAIVER OF AND RELIEF FROM E-RATE RULES ON BEHALF OF VICTIMS OF IOWA STORMS AND FLOODS

## PLEADING CYCLE ESTABLISHED

On August 21, 2008, the State of Iowa (Iowa) filed a petition for waiver of and relief from rules pertaining to the schools and libraries universal service support mechanism, also known as the E-rate program.<sup>1</sup> In the late spring and summer of 2008, Iowa experienced tornadoes and heavy rainfall that resulted in extensive flooding. Iowa estimates the replacement costs for E-rate eligible services in damaged schools and libraries to be approximately \$3 million.<sup>2</sup> Iowa requests relief similar to the E-rate program relief that was granted to Hurricane Katrina victims.<sup>3</sup> Among other things, Iowa requests that the Commission:

- re-open the Funding Year 2008 FCC Form 471 filing window for all applicants affected by the storms and floods in Iowa;
- allow affected eligible entities to receive 90 percent discounts for reconstruction and/or temporary services;
- waive the technology plan approval requirement for services requested within the window; and
- extend applicable form deadlines for affected entities.<sup>4</sup>

Interested parties may file **comments on or before October 1, 2008** and **reply comments on or before October 8, 2008**. All pleadings are to reference **CC Docket No. 02-6**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://www.fcc.gov/cgb/ecfs/</u>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>6</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>7</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>8</sup>
