The Wireline Competition Bureau seeks comment on a request from two participants in the Rural Health Care Pilot Program, As One Together for Health (ATH) and the University of Mississippi Medical Center (UMC), to merge and designate UMC as ATH's successor. Interested parties may file **comments on or before September 26, 2008** and **reply comments on or before October 3, 2008**. All pleadings are to reference **WC Docket No. 02-60**.
