## COMMENT SOUGHT ON A PETITION FILED BY CENTENNIAL COMMUNICATIONS CORP. FOR WAIVER OF SECTION 54.809 OF THE COMMISSION'S RULES UNIVERSAL SERVICE HIGH-COST FILING DEADLINES

## Comment Date: October 30, 2008 Reply Comment: November 14, 2008

The Wireline Competition Bureau seeks comment on a petition filed by Centennial Communications Corp. (Centennial) seeking an expedited waiver of the annual certification filing deadlines for universal service interstate access support (IAS) set forth in section 54.809(c) of the Commission's rules.<sup>1</sup> Centennial was designated an eligible telecommunications carrier (ETC) by the Louisiana Public Service Commission in 2004, but did not file annual certifications for IAS funding until February 2008.<sup>2</sup> Centennial requests that the filing deadlines for certifications under section 54.809(c) be waived to allow Centennial to receive IAS funding beginning as of the fourth quarter of 2005.<sup>3</sup> Alternatively, Centennial requests that the filing deadlines be waived to allow Centennial to receive IAS funding as of January 1, 2008.<sup>4</sup>

The ordering clause characterized the areas being approved as "rural high cost areas" in Louisiana. Petition at 2. In December 2007, per Centennial's request, LPSC issued a clarification letter stating that Centennial was designated an ETC in both "rural and non-rural" areas. Petition at 3, Attachment 2. Centennial filed its first annual certification for IAS support on February 4, 2008, after LPSC issued the clarification letter. Petition at 3.

Interested parties may file **comments on or before October 30, 2008** and **reply comments on or before November 14, 2008**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://www.fcc.gov/cgb/ecfs/</u>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. A sample form and directions will be sent in response.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by firstclass or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

The Commission's contractor will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. More than a one or two sentence description of the views and arguments presented generally is required.<sup>7</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>8</sup>
