ORDER

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

1. In this Order, we consider the complaint filed by Complainant¹ alleging that New Century Telecom, Inc. (New Century) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.² We conclude that New Century's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.

2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection

of a provider of telephone exchange service or telephone toll service.⁴ In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.⁵ Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.⁶ Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.⁷

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change.⁸ Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.⁹ Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act.¹⁰

4. We received Complainant's complaint on August 14, 2008, alleging that Complainant's telecommunications service provider had been changed from Verizon to New Century without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules,¹¹ we notified New Century Telecom and New Century responded on September 12,

2008.¹² New Century states in its response that authorization was received through a third party verification (TPV), but that New Century is unable to provide the TPV. Consequently, we find that New Century has failed to produce clear and convincing evidence that Complainant authorized a carrier change.¹³ Therefore, we find that New Century's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss New Century's liability below.¹⁴

5. Pursuant to Section 64.1170(b) our rules, New Century must forward to Verizon an amount equal to 150% of all charges paid by the subscriber to New Century.¹⁵ Therefore, Verizon must forward to New Century 150% of the amount, along with copies of any telephone bills issued from the company to the Complainant.¹⁶ Within ten days of receipt of this amount, New Century shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to Verizon. Complainant has the option of asking New Century to re-rate Verizon's charges based on New Century's rates and, on behalf of Complainant, seek from Verizon, any re-rated amount exceeding 50% of all charges paid by Complainant to Verizon. New Century must also send a notice to the Commission, referencing this Order, stating that it has given a refund or credit to Complainant.¹⁷ If New Century has not received the reimbursement required from Verizon within 45 days of the release of this Order, New Century must notify the Commission and Complainant accordingly. New Century also must notify the Complainant of his or her right to pursue a claim against Verizon for a refund of all charges paid to Verizon.¹⁸

6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against Nationwide Long Distance Service IS GRANTED.

7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and neither New Century and Zoom-i-Net Communications, Inc nor Verizon, Inc. may pursue any collection against Complainant for those charges.

8. IT IS FURTHER ORDERED that this Order is effective upon release.
