## COMMENT SOUGHT ON TRACFONE WIRELESS INC. PETITION FOR MODIFICATION OF PUBLIC SAFETY ANSWERING POINT CERTIFICATION CONDITION

CC Docket No. 96-45

## Comment Date: January 6, 2009 Reply Comment: January 13, 2009

The Wireline Competition Bureau seeks comment on a petition for modification filed on November 21, 2008, by TracFone Wireless, Inc. (TracFone).<sup>1</sup> The Commission conditionally granted TracFone forbearance from the requirement that eligible telecommunications carriers (ETCs) provide services over their own facilities, and granted TracFone ETC designation for the limited purpose of receiving low-income universal service support under the Lifeline support mechanism.<sup>2</sup> The Commission's grant of forbearance was conditioned on the requirement that TracFone obtain a certification from each public safety answering point (PSAP) where it provides Lifeline service confirming that TracFone provides its customers with access to basic and E911 service.<sup>3</sup> TracFone seeks to modify this condition.<sup>4</sup>

Interested parties may file **comments on or before January 6, 2009** and **reply comments on or before January 13, 2009**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. More than a one or two sentence description of the views and arguments presented generally is required.<sup>7</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>8</sup>
