## **Guard Band Licensee and Band Manager Annual Reports Are Due March 3, 2008**

By this Public Notice, the Wireless Telecommunications Bureau (Bureau) reminds certain licensees that the seventh annual reports from 700 MHz Guard Band Licensees and the sixth annual report from Access 220, LLC, a 220 MHz Band Manager,<sup>1</sup> are due March 3, 2008.<sup>2</sup> In the annual report, as required by 47 C.F.R. § 27.607, Guard Band Licensees must supply the Commission with specific information for each license held.<sup>3</sup> Guard Band Licensees should note that the basic information required in the annual reports was revised in April 2007.<sup>4</sup> In addition, these reports must be filed electronically through the Bureau's internet site at [http://esupport.fcc.gov/reports/700\\_guard/submitreport.jsp](http://esupport.fcc.gov/reports/700_guard/submitreport.jsp).<sup>5</sup> The public can view the reports at [http://wireless.fcc.gov/services/index.htm?job=about\\_reports&id=700\\_guard](http://wireless.fcc.gov/services/index.htm?job=about_reports&id=700_guard).
