**DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF
PACIFIC LIGHTNET, INC. TO SK TELECOM HOLDINGS, L.P.**

STREAMLINED PLEADING CYCLE ESTABLISHED

On February 19, 2008, Pacific Lightnet, Inc. (PLNI) and SK Telecom Holdings, L.P. (SK Telecom) (collectively, Applicants) filed an application pursuant to section 63.03 of the Commission's rules for authority to transfer control of PLNI to SK Telecom.¹ PLNI, a Hawaii corporation, provides retail and wholesale competitive local exchange, intrastate, and interstate interexchange services in Hawaii. SK Telecom is a Delaware limited partnership that currently does not provide domestic telecommunications services. The following U.S. based entity and U.S. citizens directly or indirectly own at least 10 percent of the equity of SK Telecom: SK Capital Holdings, L.P. (69.37%), Robert Seidler (13.75%), Matthew Seidler (13.75%), Peter Seidler (11.25%), and John Seidler (11.25%).² Applicants assert that none of these owners own 10 percent or more of any other telecommunications carrier. Pursuant to the terms of the proposed transaction, SK Telecom will purchase PLNI in its entirety. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(1)(ii) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.³

GENERAL INFORMATION

The Wireline Competition Bureau finds, upon initial review, that the transfer of control identified herein is acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 C.F.R. § 63.03(a), interested parties may file comments **on or before March 11, 2008**, and reply comments **on or before March 18, 2008**. Unless otherwise notified by the Commission, the Applicants may transfer control on the 31st day after the date of this notice.⁴ Comments must be filed electronically using (1) the Commission's Electronic Comment Filing System (ECFS) or (2) the Federal Government's e-Rulemaking Portal. See 47 C.F.R. § 63.03(a) ("All comments on streamlined applications shall be filed electronically . . ."); *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- Comments may be filed electronically using the Internet by accessing the ECFS, <http://www.fcc.gov/cgb/ecfs/>, or the Federal e-Rulemaking Portal, <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
