**COMMENT SOUGHT ON A PETITION BY USCOC OF ILLINOIS RSA #1, LLC, USCOC OF ILLINOIS RSA #4, LLC, USCOC OF ROCKFORD, LLC AND USCOC OF CENTRAL ILLINOIS, LLC FOR COMMISSION AGREEMENT IN REDFINING THE SERVICE AREAS OF RURAL TELEPHONE COMPANIES IN THE STATE OF ILLINOIS**

The Wireline Competition Bureau seeks comment on a petition filed by USCOC of Illinois RSA #1, LLC, USCOC of Illinois RSA #4, LLC, USCOC of Rockford, LLC and USCOC of Central Illinois, LLC, pursuant to section 54.207 of the Commission's rules, requesting the Commission's agreement with the decision of the Illinois Commerce Commission (Illinois Commission) to redefine the service area of certain rural telephone carriers at the wire center level.<sup>1</sup>

Section 54.207 of the Commission's rules, which implements section 214(e)(5) of the Communications Act of 1934, as amended, provides that a rural telephone company's service area will be its study area "unless and until the Commission and the states, after taking into account recommendations of a Federal-State Joint Board instituted under section 410(c) of the Act, establish a different definition of service area for such company."<sup>2</sup>

This is the Public Notice required by section 54.207(c)(2) of the Commission's rules.<sup>3</sup> If the Commission initiates a proceeding to consider the Petition, it must do so within 90 days of the release date of this Public Notice, pursuant to our rules.<sup>4</sup> If the Commission does not act on the Petition by **June**

**29, 2008**, the definition proposed by the Illinois Commission will be deemed approved by the Commission and shall take effect in accordance with state procedures.<sup>5</sup>

Interested parties may file comments on or before **April 30, 2008**, and reply comments on or before **May 15, 2008**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>6</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>7</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>8</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>9</sup>
