AT&T FILES COST ALLOCATION MANUAL REVISION

I. COST ALLOCATION MANUAL REVISION

1. In this public notice, we seek comment on the Cost Allocation Manual (CAM) revision filed by AT&T Southeast (formerly BellSouth Telecommunications, Inc.) on March 14, 2008. AT&T's revision adds a nonregulated service, Disaster Recover Access Links, in Section II of the CAM.

II. PROCEDURAL MATTERS

2. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.¹ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented is generally required.² Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.³

3. Interested parties may file comments on or before May 9, 2008, and reply comments on or before May 27, 2008. All such filings shall refer to the internal file number: **WCB/Pricing File No. 08-12**. Comments in this proceeding may not be filed using the Commission's Electronic Comment Filing System (ECFS).

4. Interested parties should file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.
