**COMMENT SOUGHT ON A PETITION FILED BY CENTRAL ATLANTIC PENNSYLVANIA  
PAYPHONE ASSOCIATION FOR CLARIFICATION, OR, IN THE ALTERNATIVE,  
RECONSIDERATION, OF ORDER ON RECONSIDERATION**

**CC Docket Nos. 96-45, 98-171, 90-571, 92-237, 99-200, 95-116, 98-170**

The Wireline Competition Bureau seeks comment on a petition filed by Central Atlantic Pennsylvania Payphone Association seeking clarification, or in the alternative reconsideration, of the Commission's February 14, 2008 order on reconsideration which granted the petition for reconsideration of the American Public Communications Counsel.<sup>1</sup> In that order, the Commission found that application of the Centrex-adjusted portion of the universal service line item to payphone service providers would be inconsistent with Congress' direction in section 276(b) of the Communications Act of 1934, as amended by the Telecommunications Act of 1996.<sup>2</sup>

Interested parties may file **comments on or before May 14, 2008**, and **reply comments on or before May 29, 2008**. All pleadings are to reference **CC Docket Nos. 96-45, 98-171, 90-571, 92-237, 99-200, 95-116, 98-170**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission’s rules.<sup>6</sup>
