## COMMENT SOUGHT ON REQUEST TO MERGE PENNSYLVANIA RURAL HEALTH CARE PILOT PROGRAM PROJECTS

The Wireline Competition Bureau seeks comment on a request to merge two participants in the universal service Rural Health Care Pilot Program (RHC Pilot Program), Juniata Valley Network (JVN) and Pennsylvania Mountains Healthcare Resource Development (PMHRD). JVN is a consortium of health care providers serving the Appalachian region of Pennsylvania. PMHRD is the fiduciary agent for the Pennsylvania Mountains Healthcare Alliance (PMHA), a consortium of health care providers also serving the Appalachian region of Pennsylvania. JVN and PMHRD wish to merge their respective projects and designate PMHRD as successor to JVN's RHC Pilot Program project.

Interested parties may file **comments on or before May 20, 2009**, and **reply comments on or before May 27, 2009**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>6</sup>
