On March 30, 2009, Masergy Communications Inc. (Masergy) filed a petition for clarification or review of the Wireline Competition Bureau's (Bureau) amended FCC Form 499-A Worksheet Instructions. A nonsubstantive modification to the FCC Form 499-A instructions included adding Multi-Protocol Label Switching (MPLS) as an example of "interstate telecommunications." Masergy requests additional clarification concerning contribution obligations related to MPLS. Absent clarification, Masergy requests that the Commission reverse the inclusion of MPLS in the FCC Form 499-A instructions as an example of "interstate telecommunications."

Interested parties may file **comments on or before June 8, 2009**, and **reply comments on or before June 22, 2009**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.⁵
