## MEDIA BUREAU ANNOUNCES EFFECTIVE DATE FOR REVISED FCC FORMS 301, 314, 315 AND 345

**MB DOCKET NOS. 07-294; 06-121; 02-277; 04-228, MM Docket Nos. 01-235; 01-317;  
00-244; FCC 07-217**

### Effective Date: May 21, 2009

On December 18, 2007, the Commission adopted a Report and Order and Third Further Notice of Proposed Rulemaking (the "Order") in MB Docket Nos. 07-294; 06-121; 02-277; 04-228, MM Docket Nos. 01-235; 01-317; 00-244; FCC 07-217. The *Order* adopted measures to increase participation in the broadcasting industry by small businesses and new entrants, including minority- and women-owned businesses. Some of these rule and policy changes necessitated changes to relevant FCC Forms.<sup>1</sup> On May 16, 2008, the *Order* was published in the Federal Register.<sup>2</sup> On April 6, 2009, the Commission received OMB approval for proposed changes to FCC Forms 301, 314, 315 and 345 resulting from the changes adopted in the *Order*.<sup>3</sup> On April 21, 2009, notice of OMB approval was published in the Federal Register.<sup>4</sup> Therefore, pursuant to the *Order*, the effective date for the revised forms is May 21, 2009.<sup>5</sup>
