COMMENT SOUGHT ON ALABAMA COMMERCIAL MOBILE RADIO SERVICE EMERGENCY TELEPHONE SERVICES BOARD PETITION TO REJECT TRACFONE WIRELESS INC.'S ETC SELF-CERTIFICATION

On June 2, 2009, the Alabama Commercial Mobile Radio Service Emergency Telephone Services Board (the Board), an agency of the State of Alabama, filed a petition asking the Commission to reject TracFone Wireless Inc.'s (TracFone) eligible telecommunications carrier (ETC) self-certification that it is in full compliance with the applicable 911 and enhanced E-911 obligations of the state of Alabama. The Board maintains that TracFone is not in compliance with the state's 911 and enhanced E-911 obligations, and, therefore, requests that the Commission revoke TracFone's limited ETC designation in Alabama.

Interested parties may file **comments on or before August 20, 2009**, and **reply comments on or before September 4, 2009**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the website for submitting comments.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. ⁴ Persons making oral *ex parte* presentations are reminded that memoranda

summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
