On June 23, 2009, BitWise Communications, Inc. a/k/a OmniLEC (BitWise) filed a request seeking review and reversal of three decisions of the Universal Service Administrative Company (USAC), in which USAC denied BitWise's requests to amend its 2006, 2007, and 2008 FCC Forms 499-A more than one year past the filing deadlines.¹

Interested parties may file **comments on or before August 20, 2009**, and **reply comments on or before September 4, 2009**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.²

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte*
