On July 31, 2009, the Policy Branch granted, subject to conditions, the request of EchoStar Satellite Operating L.L.C. for special temporary authority for a period of 30 days, commencing on August 3, 2009, to perform tracking, telemetry, and command (TT&C) functions with the EchoStar 5 satellite (Call Sign S2658) to execute end-of-life maneuvers boosting the satellite to a disposal orbit above the geostationary arc.
