## COMMENT SOUGHT ON CONEXIONS PETITION FOR FORBEARANCE FROM ELIGIBLE TELECOMMUNICATIONS CARRIER FACILITIES REQUIREMENT

CC Docket No. 96-45

On July 8, 2009, Conexions, LLC (Conexions), a mobile virtual network operator, filed a petition seeking forbearance from section 214(e)(1)(A) of the Communications Act of 1934, as amended, which requires that an eligible telecommunications carrier (ETC) offer the services supported by the universal service mechanisms using its own facilities or a combination of its own facilities and the resale of another carrier's services.<sup>1</sup> Conexions seeks forbearance to allow it to be designated an ETC for purposes of receiving only universal service Lifeline and Link-Up support.<sup>2</sup>

Interested parties may file **comments on or before September 9, 2009**, and **reply comments on or before September 24, 2009**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. - Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte*
