On July 15, 2009, Panora Communications Cooperative (Panora) and Prairie Telephone Co., Inc. (Prairie) filed a joint petition for waiver of the study area boundary freeze. Panora and Prairie seek a waiver of the study area boundary freeze to remove 35 access lines from Prairie's Iowa study area and include those access lines in Panora's Iowa study area.

Interested parties may file **comments on or before September 9, 2009**, and **reply comments on or before September 24, 2009**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>

summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
