**COMMENTS SOUGHT ON PETITION FOR DECLARATORY RULING AND  
CONTINGENT PETITION FOR PREEMPTION OF  
GREAT LAKES COMMUNICATIONS CORP. AND  
SUPERIOR TELEPHONE COOPERATIVE**

By this Public Notice we seek comment on a petition filed August 14, 2009, by Great Lakes Communications Corp. and Superior Telephone Cooperative (Petitioners) requesting that the Commission issue a declaratory ruling that “all matters relating to interstate access charges, including the rates therefor and revenue derived therefrom, are within [the Commission’s] exclusive federal jurisdiction and thus any attempts by state authorities to regulate interstate access charges are beyond their authority.”<sup>1</sup>

Interested parties may file comments on the Petition on or before **September 21, 2009** and reply comments on or before **October 6, 2009**. Filings in this proceeding should be captioned “Great Lakes Communications Corp. and Superior Telephone Cooperative Petition for Declaratory Ruling” and filed in WC Docket No. 09-152.

This Public Notice establishes certain procedural requirements relating to consideration of the petition for preemption. This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>2</sup> Persons making oral *ex parte* presentations are reminded that

memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>3</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>4</sup>
