## **ORDER**

Adopted: August 24, 2009 Released: August 28, 2009

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaint<sup>1</sup> alleging that Network Service Billing, Inc. (NSBI) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.<sup>2</sup> We conclude that NSBI's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection of

a provider of telephone exchange service or telephone toll service.<sup>4</sup> In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.<sup>5</sup> Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.<sup>6</sup> Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.<sup>7</sup>

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10
- 4. We received Complainant's complaint on June 22, 2009, alleging that Complainant's telecommunications service provider had been changed to NSBI without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, 11 we notified

NSBI of the complaint and NSBI responded on July 28, 2009. NSBI states that authorization was received through third party verification (TPV). We have reviewed the TPV submitted by NSBI with its response. Section 258(a) of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996<sup>13</sup> provides that, "no telecommunications carrier shall submit or execute a change in subscriber's selection of a provider of telephone exchange service or telephone toll service except in accordance with such verification procedures as the Commission shall prescribe. 14 Section 64.1120(c)(3)(iii) of the Commission's rules specifically requires that all third party verifiers "elicit, at a minimum the identity of the subscriber, [and] confirmation that the person on the call is authorized to make the carrier change..." NSBI did not satisfy this procedural requirement when its verifier asked whether the person on the call was "authorized by the telephone account owner to make changes to and/or incur charges on this telephone account." A "yes" response by the person on the call does not provide clear and convincing evidence confirming that such person was "authorized to make the carrier change" because the person on the call could have been confirming authorization only for incurring charges. The possibility of the person on the call only confirming authorization to incur charges would not meet the specific procedural requirement that the third party verifier "confirm that the person on the call is authorized to make the carrier change." Accordingly, we grant Complainant's complaint. We find that NSBI has failed to produce clear and convincing evidence of a valid authorized carrier change by the Complainant.<sup>18</sup> Therefore, we find that NSBI's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss NSBI's liability below. 19

5. NSBI must remove all charges incurred for service provided to Complainant for the first thirty days after the alleged unauthorized change in accordance with the Commission's

If Complainant is unsatisfied with the resolution of this complaint, Complainant may file a formal complaint with the Commission pursuant to Section 1.721 of the Commission's rules, 47 C.F.R. § 1.721. Such filing will be deemed to relate back to the filing date of Complainant's informal complaint so long as the formal complaint is filed within 45 days from the date of this order is mailed or delivered electronically to Complainant. *See* 47 C.F.R. § 1.719.

liability rules.<sup>20</sup> We have determined that Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and that NSBI may not pursue any collection against Complainant for those charges.<sup>21</sup> Any charges imposed by NSBI on the subscriber for service provided after this 30-day period shall be paid by the subscriber to their authorized carrier at the rates the subscriber was paying at the time of the unauthorized change.<sup>22</sup>

- 6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed against NSBI IS GRANTED.
- 7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and NSBI may not pursue any collection against Complainant for those charges.
  - 8. IT IS FURTHER ORDERED that this Order is effective upon release.
