MEDIA BUREAU SEEKS COMMENT ON HUAWEI'S LOW-COST, LIMITED CAPABILITY SET-TOP BOX CERTIFICATION

CSR-8206-Z

Comment Date: October 8, 2009

On June 1, 2009, the Commission released an order granting a request by Evolution Broadband, LLC ("Evolution") for a waiver of Section 76.1204(a)(1) of the Commission's rules,¹ which prohibits cable operators from placing into service navigation devices that perform both conditional access and other functions.² The Commission concluded that the Evolution Broadband DMS-1002 and DMS-1002-CA set-top boxes were eligible for waiver of the integration ban pursuant to the "low-cost, limited-capability" standard set forth in the Commission's 2005 *Deferral Order*.³ In the *Evolution Order*, the Commission set forth a streamlined process for other applicants to seek waivers for similarly low-cost, limited-capability devices:

If applicants certify that the capabilities of their navigation devices are low-cost, limited capability devices that are no more advanced than the [Evolution Broadband DMS-1002 and DMS-1002-CA set-top boxes] and include the full specifications of any devices for which waiver is sought, the Media Bureau will release a public notice seeking comment on those certifications for a period of ten calendar days, after which the Bureau will expeditiously grant a waiver similar to the one granted herein, deny such a waiver, or take other appropriate action.⁴

FutureWei Technologies, Inc. d/b/a Huawei Technologies (USA) ("Huawei") has filed a request for waiver pursuant to this streamlined process, certifying that its Huawei DC-730 and DC-732 set-top boxes

are low-cost, limited-capability devices that are no more advanced than the Evolution Broadband DMS-1002 and DMS-1002-CA.⁵ The Media Bureau seeks comment on this certification.⁶

This proceeding will be treated as “permit but disclose” for purposes of the Commission’s *ex parte* rules. See generally 47 C.F.R. §§ 1.1200-1.1216. As a result of the permit-but-disclose status of this proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission’s rules applicable to non-restricted proceedings.⁷

Comments and oppositions are due October 8, 2009. All filings should refer to the case identifier, CSR-8206-Z. Pleadings sent via e-mail to the Commission will be considered informal and will not be part of the official record.
