The Alliance for Community Media ("ACM") *et al.*; the City of Lansing, Michigan, and the City of Dearborn, Michigan *et al.* (collectively, "Petitioners"), have separately filed petitions for declaratory ruling pursuant to Sections 1.2 and 76.7 of the Commission's rules seeking Commission guidance regarding the carriage of public, educational and governmental ("PEG") channels. We seek comment on each of these petitions. 5

This proceeding will be treated as "permit but disclose" for purposes of the Commission's *ex parte* rules. *See generally* 47 C.F.R. §§ 1.1200-1.1216. As a result of the permit-but-disclose status of this
