## COMMENT SOUGHT ON PETITION OF MILLENNIUM TELECOM TO APPEAL A DECISION OF THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY AND TO WAIVE CERTAIN CONTRIBUTION PENALTIES

Millennium Telecom (Millennium) filed a petition on November 18, 2009, appealing a decision of the Universal Service Administrative Company (USAC) and asking that the Commission waive certain contribution deadlines and penalties.<sup>1</sup> Millennium requests relief from the application of late fees and penalties USAC assessed on Millennium arising from the company's inadvertent overstatement of its interstate telecommunications revenues on its February 2009 FCC Form 499-Q filing and misstatement of its contact information on its 2008 FCC Form 499-A filing.

Interested parties may file **comments on or before January 21, 2010, and reply comments on or before February 5, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>2</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>3</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>4</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>5</sup>
