COMMENT SOUGHT ON REQUEST TO MERGE TEXAS RURAL HEALTH CARE PILOT PROGRAM PROJECTS

The Wireline Competition Bureau seeks comment on a request to merge two participants in the universal service Rural Health Care Pilot Program (RHC Pilot Program), Texas Healthcare Network (THN) and Texas Health Information Network Collaborative (THINC).¹ The THN project application was filed by THN, as lead applicant and fiduciary agent for THN, Texas Organization of Rural & Community Hospitals (TORCH), Community Hospital Foundation of Texas (CHFTX), and Southeast Texas Healthy System (STHS).² THN has requested to withdraw from participation in the RHC Pilot Program.³ TORCH, a member of the THN consortium, has requested to merge and designate THINC as THC's successor.⁴ CHRISTUS Health will serve as the fiduciary agent for the merged projects.⁵

Interested parties may file **comments on or before March 20, 2009** and **reply comments on or before March 27, 2009**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁶

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁷ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁸ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁹
