## COMMENT SOUGHT ON PETITION FILED BY HARGRAY TELEPHONE COMPANY FOR WAIVER OF UNIVERSAL SERVICE FUND HIGH-COST FILING DEADLINE

The Wireline Competition Bureau seeks comment on a petition filed by Hargray Telephone Company seeking a waiver of the October 1, 2006 and October 1, 2007 filing deadlines set forth in section 54.301(b) of the Commission's rules for receipt of universal service funds.<sup>1</sup>

Interested parties may file **comments on or before April 20, 2009**, and **reply comments on or before May 5, 2009**. All pleadings are to reference **CC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>2</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the website for submitting comments.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>3</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>4</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules <sup>5</sup>
