## COMMENT SOUGHT ON A PETITION BY CELLULAR PROPERTIES, INC. FOR AGREEMENT IN REDEFINING THE SERVICE AREA OF ILLINOIS CONSOLIDATED TELEPHONE COMPANY

CC Docket No. 96-45

The Wireline Competition Bureau seeks comment on a petition filed by Cellular Properties, Inc., pursuant to section 54.207 of the Commission's rules, requesting the Commission's agreement with the decision of the Illinois Commerce Commission (Illinois Commission) to redefine the service area of Illinois Consolidated Telephone Company.<sup>1</sup>

Section 54.207 of the Commission's rules, which implements section 214(e)(5) of the Communications Act of 1934, as amended (the Act), provides that a rural telephone company's service area will be its study area "unless and until the Commission and the states, after taking into account recommendations of a Federal-State Joint Board instituted under section 410(c) of the Act, establish a different definition of service area for such company."<sup>2</sup>

This is the public notice required by section 54.207(c)(2) of the Commission's rules.<sup>3</sup> If the Commission initiates a proceeding to consider the Petition, it must do so within 90 days of the release date of this public notice, pursuant to the Commission's rules.<sup>4</sup> If the Commission does not act on the Petition by **July 2, 2009**, the definition proposed by the Illinois Commission will be deemed approved by the Commission and shall take effect in accordance with state procedures.<sup>5</sup>

Interested parties may file **comments on or before May 4, 2009**, and **reply comments on or before May 19, 2009**. All pleadings are to reference **CC Docket No. 96-45**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>6</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption.
