WIRELESS TELECOMMUNICATIONS BUREAU GRANTS 700 MHz BAND LICENSES

Auction Event No. 73

Report No. AUC-73 (Auction No. 73)

On March 18, 2008, the Federal Communications Commission completed the auction of 1,099 licenses in the 698-806 MHz Band (“700 MHz Band”) (Auction No. 73).¹ After a preliminary review of the FCC long-form applications (FCC Form 601), the applications listed in Attachment A to this Public Notice were accepted for filing.² Upon further review, we find that the applications listed in Attachment A are complete and conform to the Commission’s rules.³ Furthermore, the Commission has received full payment, as required by Section 1.2109(a) of its rules,⁴ for the licenses listed in Attachment A.⁵

Accordingly, by this Public Notice, we announce the grant of the licenses listed in Attachment A.⁶ We grant these licenses pursuant to Section 309(a) of the Communications Act, 47 U.S.C. § 309(a), and section 0.331 of the Commission’s rules, 47 C.F.R. § 0.331, because it will serve the public interest, convenience, and necessity.⁷
