**COMMENT SOUGHT ON PETITION FOR CLARIFICATION AND RECONSIDERATION  
OF THE WIRELINE COMPETITION BUREAU'S TELEPACIFIC ORDER FILED BY AT&T  
INC., CENTURYLINK, SUREWEST COMMUNICATIONS, AND VERIZON**

On April 30, 2010, the Wireline Competition Bureau (Bureau) released an order granting in part the request of U.S. TelePacific Corp. (TelePacific) for review of a universal service contribution decision of the Universal Service Administrative Company (USAC).<sup>1</sup> On June 1, 2010, AT&T Inc., CenturyLink, SureWest Communications, and Verizon filed a joint petition asking the Bureau to clarify or reconsider certain aspects of that order.<sup>2</sup> The Bureau seeks comment on this petition.

Interested parties may file **comments on or before July 6, 2010**, and **reply comments on or before July 21, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
