## **COMMENTS SOUGHT ON CENTURYLINK PETITION FOR WAIVER OF DEADLINE TO IMPLEMENT NUMBER PORTABILITY PORTING INTERVAL AND VALIDATION REQUIREMENTS**

**WC Docket No. 07-244**  
**CC Docket No. 95-116**

On June 7, 2010, CenturyLink filed a petition pursuant to section 1.3 of the Commission's rules seeking a waiver of the August 2, 2010, deadline for implementation of one-business day number porting.<sup>1</sup> The Commission's *Porting Interval Order* mandated that providers subject to local number portability (LNP) rules complete simple wireline-to-wireline and simple intermodal port requests within one business day.<sup>2</sup> CenturyLink requests a limited waiver of this requirement (*i.e.*, an extension of time) until May 1, 2011, to implement the one-business day porting requirement.<sup>3</sup> CenturyLink states that due to the recent merger of CenturyTel with Embarq Systems, CenturyLink is in the midst of integrating two operating systems and believes that in its case, strict compliance with the August 2, 2010 deadline would be costly, wasteful, and harmful to the public.<sup>4</sup>

Interested parties may file comments on the CenturyLink Petition on or before **June 29, 2010** and reply comments on or before **July 6, 2010**. Filings in this proceeding should be captioned "CenturyLink Petition for Waiver of Deadline" and filed in **WC Docket No. 07-244** and **CC Docket No. 95-116**.

Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>5</sup> Comments filed through the ECFS can be sent as an electronic file via the

Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of the proceeding, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking numbers. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the *ex parte* rules.<sup>6</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>7</sup> Other requirements pertaining to oral and written presentations are set forth in section 1.1206(b) of the rules.<sup>8</sup>
