## COMMENT SOUGHT ON INCONTACT, INC.'S APPLICATION FOR REVIEW OF A DECISION BY THE WIRELINE COMPETITION BUREAU

The Commission seeks comment on an Application for Review filed by inContact, Inc. (inContact).<sup>1</sup> On May 7, 2010, the Bureau denied a petition for review and reversal of a decision of the Universal Service Administrative Company (USAC) as procedurally defective and moot.<sup>2</sup> InContact seeks review of this decision<sup>3</sup>

Interested parties may file **comments on or before July 26, 2010**, and **reply comments on or before August 9, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
