**COMMENT SOUGHT ON CRICKET COMMUNICATION INC.'S
PETITION FOR FORBEARANCE FROM ELIGIBLE TELECOMMUNICATIONS CARRIER
SERVICE AREA REQUIREMENT**

The Wireline Competition Bureau seeks comment on a petition filed on June 21, 2010, by Cricket Communications, Inc. (Cricket), a wireless telecommunications carrier.¹ Cricket has previously sought designation as an eligible telecommunications carrier (ETC) from the Commission for certain areas in New York, North Carolina, Tennessee, Virginia, and the District of Columbia for the limited purpose of participating in the universal service low-income Lifeline and Link Up programs and does not request ETC designation to receive universal service high-cost support.² Cricket seeks forbearance from the definition of service area contained in section 214(e)(5) of the Communications Act of 1934, as amended, and section 54.207 of the Commission's rules so that it can be designated a limited-purpose ETC in service areas served by rural telephone companies without seeking to redefine those service areas.³

Interested parties may file **comments on or before July 26, 2010**, and **reply comments on or before August 10, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁴

- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁵ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁶ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁷
