## **ORDER**

Adopted: July 28, 2010 Released: July 29, 2010

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaints<sup>1</sup> alleging that Network Services Billing, Inc. (NSBI) changed Complainants' telecommunications service providers without obtaining authorization and verification from Complainants in violation of the Commission's rules.<sup>2</sup> We conclude that NSBI's actions did result in unauthorized changes in Complainants' telecommunications service providers and we grant Complainants' complaints.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection of a provider of telephone exchange service or telephone toll service.<sup>4</sup> In the *Section 258 Order*, the Commission

adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur. Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures. Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10
- 4. We received Complainants' complaints alleging that Complainants' telecommunications service providers had been changed to NSBI without Complainants' authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, we notified NSBI of the complaints and NSBI responded. NSBI states that authorizations were received and confirmed through third party verifications (TPVs). We have reviewed the TPV that NSBI submitted with its response. In each case, during the course of the TPV, the verifier recited a list of telephone numbers

presumably associated with the business, but did not specifically elicit the "telephone numbers to be switched." Our rules require that the TPV elicit the number that are to be *switched*, rather than merely verifying numbers associated with a business or residence, or for what purpose the numbers are used. As we emphasized in the *Fourth Report and Order*, "any description of the carrier change transaction...shall not be misleading." We find that NSBI has failed to produce clear and convincing evidence that Complainant's authorized carrier changes. Therefore, we find that NSBI's actions resulted in unauthorized changes in Complainants' telecommunications service providers and we discuss NSBI's liability below.

- 5. NSBI must remove all charges incurred for service provided to Complainants for the first thirty days after the alleged unauthorized change in accordance with the Commission's liability rules. We have determined that Complainants are entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and that neither the Complainants authorized carrier nor NSBI may pursue any collection against Complainants for those charges. Any charges imposed by NSBI on the subscribers for service provided after this 30-day period shall be paid by the subscribers to the authorized carrier at the rates the subscribers were paying to the authorized carriers at the time of unauthorized change of telecommunications service provider. The first thirty days after the unauthorized carrier at the rates the subscribers were paying to the authorized carriers at the time of unauthorized change of telecommunications service provider.
- 6. Accordingly, IT IS ORDERED that, pursuant to section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaints filed against NSBI ARE GRANTED.
- 7. IT IS FURTHER ORDERED that, pursuant to section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainants are entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and NSBI may not pursue any collection against Complainants for those charges.
