On July 28, 2010, the Satellite Division granted, with conditions, special temporary authority to SES Americom, Inc. to operate its Ku-band space station, AMC-4, at the 67° W.L. orbital location in the conventional Ku-band frequencies of 11.7-12.2 GHz (space-to-Earth) and 14.0-14.5 GHz (Earth-to-space) and in the extended Ku-band frequencies of 11.45-11.7 GHz (space-to-Earth) and 13.75-14.0 GHz (Earth-to-space) to provide fixed-satellite service from the 67° W.L. orbital location. The Satellite Division had previously granted SES Americom special temporary authority to conduct telemetry, tracking and telecommand operations necessary to drift AMC-4 to and maintain it at the 67° W.L. orbital location.

On July 23, 2010, the Satellite Division granted, with conditions, special temporary authority to PanAmSat Licensee Corp. to operate the Galaxy 14 space station outside the +/- 0.05° east/west station-keeping box previously authorized. Accordingly, PanAmSat is authorized, for a period of 30 days to operate the communications payload aboard the Galaxy 14 space station in the 3700-4200 MHz (space-to-Earth) and 5925-6425 MHz (Earth-to-space) frequency bands outside the +/-0.05° east/west station-keeping box.
