**COMMENT SOUGHT ON PETITION OF VIRGIN MOBILE FOR  
LIMITED DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER  
IN ALABAMA**

The Wireline Competition Bureau seeks comment on a petition filed January 15, 2010, by Virgin Mobile USA, L.P. (Virgin Mobile), a provider of commercial mobile radio services.<sup>1</sup> Virgin Mobile seeks designation as an eligible telecommunications carrier (ETC) in the state of Alabama.<sup>2</sup> Virgin Mobile seeks ETC designation for the limited purpose of participating in the universal service low-income Lifeline program and does not request ETC designation to receive universal service high-cost support.<sup>3</sup>

Interested parties may file **comments on or before March 1, 2010**, and **reply comments on or before March 16, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>4</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
