**WIRELINE COMPETITION BUREAU ANNOUNCES COMMENT AND REPLY COMMENT
DATES FOR THE ELECTRONIC TARIFF FILING SYSTEM
NOTICE OF PROPOSED RULEMAKING**

By this Public Notice, the Wireline Competition Bureau announces that the Electronic Tariff Filing System Notice of Proposed Rulemaking (*ETFS NPRM*)¹ was published in the Federal Register today, August 11, 2010,² starting the pleading cycle in WC Docket No. 10-141. Accordingly, comments are due on Friday, September 10, and reply comments are due on Monday, September 27.³ Commenters must follow the filing instructions provided in Section IV.B. of the NPRM.⁴
