**WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON REQUEST BY  
SOUTH CAROLINA EDUCATIONAL TELEVISION COMMISSION FOR WAIVER TO GRANT  
GEOGRAPHIC SERVICE AREAS TO EDUCATIONAL BROADBAND SERVICE STATIONS  
LICENSED AS SECONDARY STUDIO-TO-TRANSMITTER LINKS**

On August 6, 2010, South Carolina Educational Television Commission (SCETV) filed a request for waiver of Section 27.1206 of the Commission's Rules to grant geographic service areas (GSAs) to Educational Broadband Service (EBS) licenses that were not awarded GSAs because they were originally licensed as studio-to-transmitter links on a secondary basis.

SCETV, a state governmental entity in South Carolina, is the long-time operator of an EBS network.<sup>1</sup> SCETV's EBS network consists of over 65 constructed EBS facilities that provide multi-channel coverage of schools and other educational sites across South Carolina.<sup>2</sup> In late 2009, after an extensive South Carolina state-managed bidding process, SCETV entered into separate EBS excess capacity lease agreements with Clearwire Spectrum Holdings III (Clearwire) and DigitalBridge Spectrum Corp. (DigitalBridge) under which one or the other lessee will use excess capacity of each SCETV station, including the stations subject to this waiver request.<sup>3</sup> Commission approval for these leases has been obtained.<sup>4</sup>

On September 25, 1998, the Commission released the *Two-Way Order*, which, among other things, granted all Instructional Television Fixed Service (ITFS) licensees a Protected Service Area (PSA) and individual protection to all receive sites registered through the date of the adoption of the *Two-Way Order*.<sup>5</sup> In the *Two-Way Reconsideration Order*, the Commission affirmed its decision.<sup>6</sup> In the *Two-Way*

*Second Reconsideration Order*, however, the Commission reversed its decision and concluded that point-to-point ITFS stations authorized on a secondary basis should not receive PSA protection because secondary stations, usually studio to transmitter links, have not traditionally been given protection relative to primary stations.<sup>7</sup> SCETV has multiple EBS stations that did not receive PSAs or GSAs because they were originally licensed as secondary studio-to-transmitter links.

On July 29, 2004, the Commission released the *BRS/EBS R&O*, which granted all ITFS incumbents a GSA based on their existing PSA.<sup>8</sup> Because the stations that are the subject of the Waiver Request did not have PSAs, they did not receive GSAs.<sup>9</sup>

SCETV states that it is transitioning its EBS facilities from a traditional one-way video model to a model that relies on wireless broadband deployments in conjunction with its lessees Clearwire and DigitalBridge.<sup>10</sup> SCETV contends that unless the Stations are able to obtain GSAs, there will be significant coverage gaps in SCETV's and its lessee's networks.<sup>11</sup> SCETV requests that the Stations be granted GSAs only for those areas that are outside the GSAs of neighboring co-channel EBS stations.<sup>12</sup>

### Procedural Matters

Comments on the request are due **September 29, 2010**. Reply comments are due **October 12, 2010**. All filings should reference the docket number of this proceeding, WT 10-187.

This proceeding has been designated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>13</sup> Parties making oral *ex parte* presentations in this proceeding are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list

the subjects discussed.<sup>14</sup> More than a one- or two-sentence description of the views and arguments presented is generally required.<sup>15</sup>
