**DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF  
INMATE CALLING SOLUTIONS, LLC D/B/A ICSOLUTIONS TO CENTRIC GROUP, LLC**

**STREAMLINED PLEADING CYCLE ESTABLISHED**

On September 1, 2010, Texas ICS Holding, LLC (TICS), Centric Group, LLC (Centric) and Inmate Calling Solutions, LLC d/b/a ICSolutions (ICS) (collectively, Applicants) filed an application pursuant to section 63.03 of the Commission's rules to transfer control of ICS to Centric.<sup>1</sup> TICS, a Texas limited liability company was formed in 2008 for the purpose of acquiring ICS. Currently, TICS owns ninety-nine percent of ICS. ICS, a California limited liability company, provides institutional calling services in thirty-one states. Centric, a Delaware limited liability company, is a holding company with subsidiaries that provide a variety of non-telecommunications services to inmates. The following U.S. citizens own at least 10 percent of the equity of Centric: Andrew C. Taylor (16.42%); Jo Ann Kindle (16.42%); Kelly A. Taylor (11.08%); Christine Taylor Broughton (11.08%); Patricia A. Taylor (11.08%); Alison Taylor Kindle (11.08%); Mary Carolyn Kindle (11.08%). Pursuant to the terms of the proposed transaction, Centric will purchase ninety-nine percent of the equity ownership of ICS from TICS. Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(1)(ii) of the Commission's rules and that a grant of the application will serve the public interest, convenience, and necessity.<sup>2</sup>

**GENERAL INFORMATION**

The Wireline Competition Bureau finds, upon initial review, that the transfer of control identified herein is acceptable for filing as a streamlined application. The Commission reserves

the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 C.F.R. § 63.03(a), interested parties may file comments **on or before October 7, 2010**, and reply comments **on or before October 14, 2010**. Unless otherwise notified by the Commission, the Applicants may transfer control on the 31<sup>st</sup> day after the date of this notice.<sup>3</sup> Comments must be filed electronically using (1) the Commission's Electronic Comment Filing System (ECFS) or (2) the Federal Government's e-Rulemaking Portal. See 47 C.F.R. § 63.03(a) ("All comments on streamlined applications shall be filed electronically . . ."); *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
