## COMMENTS INVITED ON APPLICATION OF CYPRESS COMMUNICATIONS OPERATING COMPANY, LLC TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

WC Docket No. 10-196 Comp. Pol. File No. 943

**Comments Due: October 12, 2010** 

Section 214 Application Applicant: Cypress Communications Operating Company, LLC

On August 4, 2010, Cypress Communications Operating Company, LLC (Cypress or Applicant), located at 4 Piedmont Center, Suite 600, 3565 Piedmont Road, Atlanta, Georgia 30305, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Communications services in Pennsylvania. On August 30, 2010, Cypress filed an amendment to its application in order to clarify which services would be affected by the proposed discontinuance, and to update the record regarding corrected notice to customers.<sup>1</sup> Accordingly, Cypress's application is deemed complete as of August 30, 2010.

Cypress indicates that it currently provides bundled telecommunications services to small and medium-sized businesses located in multi-tenant commercial office buildings in major metropolitan markets in the U.S. Cypress explains that its integrated service bundles include local, long distance, and international telecommunications services; high-speed Internet connectivity; e-mail services; fully-managed firewall services; web hosting; virtual private networks; feature-rich digital desktop stations; calling cards; audio and web conferencing; and digital business television. Cypress indicates that it has identified three customer sites where revenue has been declining for some time. Accordingly, Cypress states that it plans to discontinue all of the above-mentioned services that it provides at these sites in an effort to maintain its operating network in the most efficient manner.<sup>2</sup> Specifically, Cypress indicates that it plans to discontinue service to two customers in Blue Bell, Pennsylvania and four customers in Berwyn, Pennsylvania (collectively Service Areas). In its updated notice to customers, Cypress states that it plans to discontinuance will not result in harm to affected customers because customers will have the opportunity to select another telecommunications provider, and numerous CLECs and ILECs in

the affected areas continue to offer some or all of the services customers have been receiving from Cypress. Cypress indicates that it mailed an initial notice to affected customers on August 3, 2010, and that it subsequently mailed a revised notice of the proposed discontinuance to all affected customers in accordance with the requirements of section 63.71(a) of the Commission's rules on August 26, 2010. Cypress states that it is considered non-dominant with respect to the services to be discontinued.

In accordance with section 63.71(c) of the Commission's rules, Cypress's application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies Cypress that the grant will not be automatically effective. In its revised notice to customers, Cypress indicates that it anticipates discontinuing service on October 26, 2010, subject to regulatory approval. Accordingly, pursuant to section 63.71(c), absent further Commission action, Cypress may terminate the affected services in the Service Areas on or after **October 28, 2010**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **October 12, 2010**. Such comments should refer to **WC Docket No. 10-196 and Comp. Pol. File No. 943**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <u>http://www.fcc.gov/cgb/ecfs/</u>. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, filers should send an e-mail to <u>ecfs@fcc.gov</u>, and include the following words in the body of the message, "get form." A sample form and directions will be sent in response.
