**COMMENTS INVITED ON APPLICATION OF VERIZON CALIFORNIA INC.,
VERIZON FLORIDA LLC, GTE SOUTHWEST INCORPORATED (D/B/A VERIZON
SOUTHWEST), VERIZON SOUTH INC. AND VERIZON NORTH RETAIN CO. TO
DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES**

Section 214 Application

Applicants: Verizon California Inc., Verizon Florida LLC, GTE Southwest Incorporated (d/b/a Verizon Southwest), Verizon South Inc. and Verizon North Retain Co.

On September 7, 2010, Verizon California Inc., located at 112 Lakeview Canyon Road, Thousand Oaks, CA 91362; Verizon Florida LLC, located at 201 North Franklin Street, One Tampa City Center, Tampa, FL 33602; GTE Southwest Incorporated (d/b/a Verizon Southwest), located at 600 Hidden Ridge, Irving, TX 75038; Verizon South Inc., located at 703 East Grace Street, Richmond, VA 23219; and Verizon North Retain Co., located at 600 Hidden Ridge, HQE03H09, Irving, TX 75038 (collectively Verizon or Applicants), filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Verizon's remaining service territory in California, Florida, Texas, the former Contel areas in North Carolina, Pennsylvania and Virginia (former Contel areas) and in Verizon's remaining service territory in the former GTE areas in Pennsylvania and Virginia (former GTE areas) (collectively Service Areas).

Verizon indicates that it currently offers Special Access High Capacity DS1C Service in its remaining service territory in California, Florida, Texas, the former Contel areas, and the former GTE areas. Verizon states that it also provides Special Access High Capacity DS3C service in its remaining service territory in California, Florida, Texas and the former GTE areas. Verizon indicates that these services are offered under Verizon's FCC Tariff Nos. 14 or 16. Verizon explains that its Special Access High Capacity DS1C and DS3C services provide dedicated high capacity facilities between customer designated locations or between a customer designated location and a Telephone Company designated Hub Wire Center where multiplexing is offered. Verizon further explains that its Special Access High Capacity DS1C and DS3C services provide for the transmission of isochronous bipolar serial data at the rate of 3.152 Mbps (DS1C) or 89.472 Mbps (DS3C), respectively. Verizon states that it plans to discontinue its Special Access High Capacity DS1C and DS3C services in the Service Areas as appropriate on or after December 2, 2010, subject to regulatory approval. Verizon asserts that suppliers of Special Access High Capacity DS1C and DS3C communications equipment have discontinued manufacturing the equipment required to provision these services, and as a result parts are no longer

readily available. Verizon, however, maintains that the public convenience and necessity will not be impaired by the proposed discontinuance because currently there are no customers for these services in the Service Areas. In addition, Verizon asserts that Verizon and other providers offer alternatives to the services to be discontinued including DS3s as one alternative to DS1Cs. Verizon states that it is considered dominant with respect to the services to be discontinued.

In accordance with section 63.71(c) of the Commission's rules, Verizon's application will be deemed to be granted automatically on the 60th day after the release date of this public notice, unless the Commission notifies Verizon that the grant will not be automatically effective. In its application, Verizon indicates that it anticipates discontinuing service on or after December 2, 2010, subject to regulatory approval. Accordingly, pursuant to section 63.71(c) and the terms of Verizon's application, absent further Commission action, Verizon may terminate its Special Access High Capacity DS1C and DS3C services in the Service Areas as appropriate on or after **December 2, 2010**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **November 1, 2010**. Such comments should refer to **WC Docket No. 10-199 and Comp. Pol. File No. 953**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. A sample form and directions will be sent in response.
