COMMENTS INVITED ON APPLICATION OF VI LATA COMMUNICATIONS, LLC TO DISCONTINUE INTERCONNECTED VOIP SERVICES

WC Docket No. 10-200 Comp. Pol. File No. 955

Comments Due: October 15, 2010

On **September 9, 2010, Vi Lata Communications, LLC** (Vi Lata or Applicant), located at **3350 Eastbrook Dr., Fort Collins, Colorado 80525-5731**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain interconnected Voice over Internet Protocol (VoIP) services in Colorado.¹

Vi Lata (d/b/a Front Range Internet, Inc. and FRII) indicates that it currently provides an interconnected VoIP service by the name of SureRing VoIP service to customers in Colorado. Vi Lata states that it now plans to discontinue this service and cease its operations as an Interconnected VoIP provider on October 31, 2010. Vi Lata indicates that it notified most customers about the planned discontinuance by phone and e-mail prior to September 2, 2010. Vi Lata maintains that all customers were then notified by e-mail on September 2, 2010, and notified by postal mail as of September 7, 2010. Vi Lata indicates that it has informed customers of three alternative providers for their VoIP services. Vi Lata asserts that it is an interconnected VoIP provider.

In accordance with section 63.71(c) of the Commission's rules, Vi Lata's application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies Vi Lata that the grant will not be automatically effective. In its application and notice to customers, Vi Lata indicates that it anticipates discontinuing service on October 31, 2010, subject to regulatory approval. Accordingly, pursuant to section 63.71(c) and the terms of Vi Lata's application and notice, absent further Commission action, Vi Lata may terminate its provision of interconnected VoIP services in Colorado on or after **October 31, 2010**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must

be filed with the Commission on or before October 15, 2010. Such comments should refer to WC Docket No. 10-200 and Comp. Pol. File No. 955. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to http://www.fcc.gov/cgb/ecfs/. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail.
