In addition, XM Radio is authorized to conduct Telemetry, Tracking, and Telecommand (TT&C) operations in the 2332.5-2345 MHz and 7025-7075 MHz frequency bands necessary to relocate the XM-4 space station to the 115.25° W.L. orbital location and to maintain the XM-4 space station at this location. XM Radio is also authorized to provide SDARS via XM-4 using the 2332.5-2345 MHz and 7025-7075 MHz frequency bands during the relocation to 115.25° W.L.
