WIRELINE COMPETITION BUREAU SEEKS COMMENT ON INTEGRITY COMMUNICATIONS, LTD. APPLICATION FOR REVIEW OF INTEGRITY ORDER ON RECONSIDERATION

On July 30, 2010, Integrity Communications, Ltd. (Integrity) filed an application for review of the Wireline Competition Bureau's (Bureau) *Integrity Order on Reconsideration*¹ in which the Bureau denied Integrity's request for review of a decision by the Universal Service Administrative Company under the Commission's schools and libraries universal service support program.² We seek comment on Integrity's application for review.

Interested parties may file **comments on or before November 1, 2010,** and **reply comments on or before November 8, 2010**. All pleadings are to reference **CC Docket No. 02-6**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
