WIRELINE COMPETITION BUREAU SEEKS COMMENT ON REQUEST FOR REVIEW BY IP TELCOM, INC. OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On September 30, 2010, IP Telcom Group, Inc. (IP Telcom) filed a request for review of a decision by the Universal Service Administrative Company (USAC). The Wireline Competition Bureau seeks comment on IP Telcom's request that the Commission direct USAC to waive the revision deadline and permit IP Telecom to amend its 2008 and 2009 FCC Forms 499-A.²

Interested parties may file **comments on or before November 19, 2010,** and **reply comments on or before December 6, 2010.** All pleadings are to reference **WC Docket No. 06-122.** Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³
