**REPORT AND ORDER
(Proceeding Terminated)**

By the Assistant Chief, Audio Division, Media Bureau:

1. The Audio Division considers herein the *Notice of Proposed Rule Making* ("Notice"),¹ issued at the request of Maupin Broadcasting Company ("Petitioner"), proposing the allotment of Channel 244C2 at Maupin, as its first local FM transmission service. Petitioner filed comments. No counterproposals or other comments were received in response to this *Notice*. For the reasons discussed below, we are amending the FM Table of Allotments, Section 73.202(b) of the Commission's Rules,² by allotting Channel 244C2 at Maupin.

2. **Background.** The *Notice* proposed the allotment of Channel 244C2 at Maupin, as its first local service. As stated in the *Notice*, Maupin was incorporated in 1922, and has a 2000 U.S. Census population of 411 persons.

3. **Discussion.** Accordingly, we are allotting Channel 244C2 at Maupin, as its first local service. Channel 244C2 can be allotted to Maupin consistent with the minimum distance separation requirements of the Rules with a site restriction 1.2 kilometers (0.7 miles) west located at reference coordinates 45-10-24 NL and 121-05-43 WL.

4. The Commission will send a copy of this *Report and Order* in a report to be sent to Congress and the Government Accountability Office pursuant to the Congressional Review Act, *see* 5 U.S.C. § 801(a)(1)(A).

5. **Ordering clauses.** Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, That effective February 22, 2010, the FM Table of Allotments, 47 C.F.R. Section 73.202(b), IS AMENDED, with respect to the communities listed below, to read as follows:

6. The window period for filing applications for Channel 244C2 at Maupin will not be opened at this time. Instead, the issue of opening this allotment for auction will be addressed by the Commission in a subsequent order.
