On September 17, 2010, the Commission released a notice of proposed rulemaking (NPRM) seeking comment on steps the Commission should take to improve assignment of telephone numbers – both local and toll-free – that are associated with Internet-based Telecommunications Relay Service, specifically, Video Relay Service and IP Relay.<sup>1</sup>

The Commission set the comment and reply comment deadlines for the NPRM as 30 and 45 days, respectively, after publication of the summary of the NPRM in the Federal Register. On November 2, 2010, a summary of the NPRM appeared in the Federal Register. Accordingly, interested parties may file **comments on or before December 2, 2010**, and **reply comments on or before December 17, 2010**. All pleadings are to reference **WC Docket No. 10-191**.

Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS); (2) the Federal Government's e-Rulemaking Portal; or (3) by filing paper copies.<sup>3</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. <sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. <sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules. <sup>6</sup>
